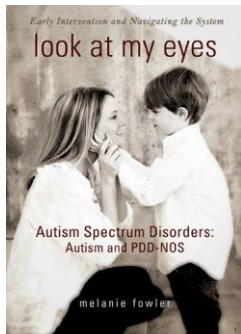

Seth and Melanie Fowler's days are fraught with the struggles of raising a child with autism. They spent a year cleaning feces off the walls and carpets of their son's room daily before they learned behavioral techniques that—gradually—taught him to stop. They scratched and clawed their way through bureaucracy to obtain the early childhood intervention that Melanie, who has a master's degree in special education, knew their son, William, desperately needed. They uneasily eyed the divorce statistics for parents of children with special needs, which are unquestionably higher than those of typical families, according to Dr. Laura Marshak... **Medicaid Buy-in for Children** (this has been for adults only until now) program on January 1, 2011. This program can help pay medical bills for children with disabilities. It helps families who need health insurance, but make too much money to get traditional Medicaid. Families "buy in" to Medicaid by making a monthly payment (premium). To qualify, children must be under age 18, meet certain disability criteria, meet income limits, and meet other requirements. To get more information on this program, please **call 2-1-1**. 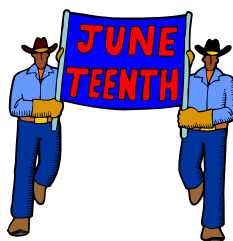

**For 2011 there are a number of Tarrant County grant programs providing caregiver respite for:**

- **Care of Older Adults\***
- **Care of Adults with physical disabilities\***

\*To qualify for these programs, the person must require 8+ hours of care per week and have safety needs, as well as need assistance with Activities of Daily Living, such as bathing, dressing, walking or eating.

- **Care of adults with Intellectual & Developmental Disabilities (IDD)\*\***

\*\*Adults 22-59 with income over Medicaid guidelines. Cannot be enrolled in a Medicaid Waiver Program. This program is specifically designed to give caregivers a “break” that meets their needs ~ like a weekend away, a few Saturdays out, help in providing the “to & from” for activities like Arc dances or Special Olympics. With this grant caregivers have a variety of individualized options, including being able to hire/pay family friends or relatives.

The ADRC serves as the screening door for these programs. Please call the Aging and Disability Resource Center at 1-888-730-2372 to see if you qualify for any of the respite programs currently being offered in Tarrant County.

**Area Agency on Aging Benefits Counseling Program**

serves Tarrant County residents, offering in-person and telephone assistance with Medicare, Medicaid, advance directives, and options for long term services and support. Benefits counselors also give presentations to community groups regarding these topics. **Call the ADRC at 1-888-730-2372 and you will be transferred to a benefits counselor.**

**A Matter of Balance** is a falls prevention program specifically designed to reduce the fear of falling and improve activity levels among older adults. Classes are available for Tarrant County residents who are 60 and older.

**Texas Healthy Lifestyles** is a diabetes self-management program for adults age 60 and older with diabetes, at risk of diabetes, or caring for someone with diabetes.

- Tools to deal with problems such as pain, insomnia, fatigue, isolation, and frustration
- Appropriate exercise for maintaining and improving strength, flexibility and endurance
- Appropriate use of medications
- Communicating effectively with family, friends and health professionals
- Making informed treatment decisions

They also learn to set their own goals and create step-by-step plans to improve their health.

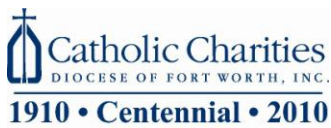


**Camp El Tesoro Inclusion Program** - Camp Fire USA's Camp El Tesoro, outside Granbury, Texas, is a summer resident camp for children age 6-16 with traditional activities like hiking, canoeing, horseback riding, swimming, and crafts. El Tesoro is unique in that it has an inclusion program. Each summer, children with mild physical and cognitive disabilities are mainstreamed into cabin groups and camp activities in each session. The campers are assigned their own "camper buddy," a counselor with special training, to ensure the children fully enjoy camp. The most

common disabilities of campers who have participated in the inclusion program are Down syndrome, autism, OCD, PDD, Asperger's and Fragile X syndrome. Call soon, as space is limited. ### **Disability Services Reduced by State of Texas** **Ms. Susan Garnett, Deputy CEO of MHMRTC**

If you haven't heard about the budget crisis facing the state of Texas, you have been asleep or out of the state for the last several months. The legislative discussions and votes over a \$ 27 billion shortfall for the next two years have created a very stressful situation for families who rely on the assistance and support for their family member with disabilities. Original proposals were to reduce or even eliminate many of the programs we count on. There was a huge effort by advocacy groups, families, and providers to minimize the amount of the budget cuts. The overwhelming efforts to educate the legislators did have an impact. Ms. Susan Garnett will speak to us about all the changes in the state budget and how they affect services we receive. What are the changes to HCS, CLASS, CBA and TxHmL? Has Medicaid been reduced? Were Medicaid Waiver waiting lists impacted? How many years must we wait now before our child is eligible for HCS or CLASS? How was MHMR affected? What about SSI and Special Education? Were there changes to Supported Home Living, Foster Companion Care, Therapy and Medical Care under the HCS program? These and many other questions will be addressed at this meeting. As the Deputy CEO at MHMR of Tarrant County, Ms. Susan Garnett is very knowledgeable of the services for people with disabilities that were affected by the Texas Legislature's new budget. This is your opportunity to get informed about all of the latest changes. Whether you are a parent, a service provider or a professional in the disability field, you'll not want to miss this very current information concerning the status of disability services in the state of Texas.

There will also be a roundtable discussion about the role that fathers play in the life of a child with disabilities. It will be facilitated by two veteran fathers who have children with significant disabilities. Please bring your thoughts and experiences to share with the group, honoring Father's Day month.

## [Redefining the Rules Governing Service Animals Covered by the ADA](#)

Service animals play an integral role in the lives of many individuals with disabilities, providing assistance in a wide variety of ways so that they can have the freedom to go about their daily activities. For this reason, Title III of the Americans with Disabilities Act (ADA) requires that places of public accommodation, such as [on public transportation] hotels, restaurants and retail stores, accommodate individuals with disabilities who use service animals. However, when the Department of Justice (DOJ) originally issued its Title III regulation in the early 1990s, the Department did not define the parameters of...

**New Medicaid Identification Card** - DARS consumers who are Medicaid recipients soon will receive a new plastic credit card-type identification card (Your Texas Benefits Medicaid card) to replace their paper Medicaid ID form. Paper ID forms mailed in May tell recipients about the card and direct them to a Web site ([www.YourTexasBenefits.com](http://www.YourTexasBenefits.com)) and a toll-free number (1-800-252-8263) for more details.

Those who depended on the paper ID letter to confirm Medicaid coverage each month will still be able to get that information by dialing 2-1-1 (pick a language, then pick option 2).

Most recipients who have Medicaid will get the card in June. Along with the card, they will receive instructions on how to use it, details explaining the information printed on each section of the card, and a list of helpful phone numbers.

The card is part of a new system that uses digital technology to simplify the process of verifying a person's Medicaid eligibility and make it more efficient. The two main elements of the system are the Your Texas Benefits Medicaid card and a new secure Web site where providers can get current information on a person's eligibility and to access each recipient's history of Medicaid services and treatments. Recipients who wish to do so can opt out of this feature, which is expected to be available before the end of 2012.
